WHAT'S THE RUSH? Rush Limbaugh has temporarily halted the launch of the USA Network's "After the Rush" program hosted by Aaron Harber. Rush Limbaugh's EFM Management filed a \$20 million lawsuit against them alleging there would "be some confusion between his (Harber's) liberal show" and Limbaugh. The show was scheduled to begin broadcasting this week. In a press release, Harber said, "This is a frivolous suit. How could we have caused \$20 million in damages before we even get on the air? I hope the court slaps him silly." USA said the American Civil Liberties Union has agreed to take on the case on behalf of the network. No word on when the program will be available.

WILL CANADA BEAT THE U.S.A. TO DIGITAL? Canada has moved one step closer to the introduction of DAB as Canada's Task Force on the Introduction of Digital Radio released its recommendations to guide the development of detailed digital radio coverage areas. The recommendations, in the form of seven guiding principles for the allocation of digital radio coverage, advocate digital replacement coverage for both AM and FM stations in the allocated L-band frequency (1.452-1.492 MHz). WASHINGTON THIS WEEK

As the official U.S. DAB testing is wrought with delays, USA Digital is quietly, but methodically, plodding along with field tests on its own IBOC (In-Band On-Channel) digital broadcasting system. In a copyrighted story in *Radio World*, USA Digital's system is one of five that the Electronic Industries Association/National Radio Systems Committee is testing, and is reportedly up and running "very well" in field tests on WGCI (AM) and WBBM-FM, both Chicago. The EIA/NRSC's testing of five different systems at the NASA Lewis Research Center has hit another snag, forcing the date that field testing would begin from this month to near year's end. After the EIA/NRSC completes all of its lab and field testing, it will make recommendations to the FCC.

The Commission has remanded two competing applications for hearing for a new FM station on 102.1 MHz at Sylvester, Georgia. The competing applications of Thomas W. Lawhorne and CAM Broadcasting, Inc. were sent to an ALJ on basic qualifying issues.

ELSEWHERE

Nearly three months after Howard Stern's "funeral" broadcast from Cleveland was literally cut short, the man accused of severing a satellite feeder cable pleaded guilty to the act. William Alford, a former assistant engineer for WMMS, plead guilty to disruption of public service and criminal trespassing after he cut the cable carrying WNCX/Stern's live broadcast celebrating a ratings victory over WMMS and WMJI. Sentencing has been set for September 28.

Inside Radio reports WRBQ (Q105) Tampa is hitting the tube again with a "humorous country version of MTV," according to GM David Manning. Dave McKay will be on channel 32 as VJ from 5 am to 7 am beginning October 5. Unlike the radio/TV simulcast they did in the '80s, this show will be separate from the radio broadcast, but will utilize traffic reports, news, and other bits from the radio studio.

The Morningstar network began broadcasting from its new Nashville studios August 25th, and has added several new people. Scott Thunder joins them from KCMS-FM, Seattle, as PD. Chris Ruleman is on from noon to 5 pm. Wade McShane helps out in morning drive, Suzanne Strickland is on late evenings. Stephanie McKenna and Fred Myrick also join the staff.

WASHINGTON THIS WEEK

The Radio Advertising Bureau, in conjunction with the National Association of Broadcasters, has released a pamphlet on the "New Radio Advertising Consumer Leasing Disclosure Legislation." The pamphlet has been written to eliminate a lot of the legalese from the bill President Clinton signed this week. The RAB has mailed copies to hundreds of auto makers and agencies. If you'd like a copy, and you're a member of either organization, you can access it via their on-line fax services.

The NAB Radio Show will hold panel discussions on how the FCC enforces its EEO and indecency rules and how to attract a diverse workforce. The FCC panel will be Saturday, October 15 from 10:30-11:45 am. The diverse workforce panel will be Friday October 14, from 9-10:15 am. For more information contact NAB's free fax-on-demand service at 301-216-1847.

ELSEWHERE

In the Ft. Myers-Naples area, Beasley Broadcasting will combo its news/talker WWCN, North Ft. Myers and rocker WRXK-FM, Bonita Springs with its CHR LMA partner, WXKB, Cape Coral. Beasley will spend \$2.7 million on the purchase. In Naples, country WCKT, Lehigh Acres will double up with standards WIXI, Naples Park, as Radio Equity Partners hands over \$3.35 million to Wodlinger Broadcasting for the privilege.

Billboard magazine reports that diet and exercise guru Richard Simmons will launch his own two hour "motivational" show, which will air weekdays from 10 p.m. to midnight ET on the Westwood One net. Simmons wanted to do the show that late to allow for his extensive travel schedule. The show should be available in January, 1995. Commenting on the type of stations Westwood will target for the show, producer Marcia Hrichison says they'll target AM talk stations initially, but also said, "there are a lot of soft rock stations with low numbers."

Arbitron unveiled a Windows-based diary scanning system that will allow diary reviewers to do their work at a computer screen, whether they're in Laurel, or someday, in other markets. Each diary is scanned on to an optical disk, which is used by editors to review each page. All editing will continue to be done by hand, not assigned by the computer. Currently, the news system is only being utilized for 20 markets during the Fall '94 survey period. Arbitron claims the system will give clients quicker access to diary review. The system was designed through a joint venture with IBM.

Talk about a plague with this Spring's book. . . Arbitron has had to reissue its NINTH market report as they found crediting problems in the Salisbury/Ocean City, MD book. Oldies WQHQ, Salisbury, MD, will pick up some listening that was given to WQSR, Baltimore. Oldies WLBW, Fenwick Island, DE, and classic rocker WLFX, Ocean Pines, MD, will get a few more mentions after they weren't credited for exact frequency mentions in some diaries.

Network listening took a huge hit in the just-released RADAR 49 survey. Overall network listening was down 8.3% over RADAR 48. Paul Harvey, as usual, lead in program listening while ABC's Prime was first overall.

The Interep Radio Store released its exclusive analysis of Arbitron and AccuRatings based on the Spring 1994 audience data, the first survey in which Arbitron officially published P1 listening estimates. P1 (First Preference) listening is defined similarly to AccuRatings' Core listening measurements, the central component of AccuRatings' research. Once again a P1 vs. Core results analysis shows surprising similarity in the markets studied. One significant format specific difference emerged. Of those stations appearing within the top 10 in both the AccuRatings and Arbitron surveys, Arbitron's P1 estimates for Adult Contemporary stations were between 20% and 37% higher than the Core Listener figures reported in AccuRatings for both Persons 12+ and Adults 25-54. Arbitron defines a radio station's P1 listeners as those who listen to that station for more quarter-hours than any other single station. AccuRatings defines a station's Core Listeners as those who say that they listen to that station more than any other. The analysis is based on the following markets: New York, Los Angeles, Chicago, San Francisco, Philadelphia, Detroit, Dallas, Boston, San Diego and Pittsburgh.

Radio station KOST, Los Angeles has officially lifted their ban on same-sex music call-ins. The L.A. Times reported that the nightly "Love Songs" show had just started experimenting with same-sex dedications for the past month in response to a letter that was written by a listener. The listener had originally called in a request and was denied on the grounds that "same-sex dedications might corrupt your listeners and were against station policy unless the dedication was made using initials or a nickname such as "Poochie"". The listener sent off a letter to the station that said "If I remained gay after being bombarded all my life with heterosexual images, what are the changes that a small amount of homosexual images will change the...heterosexual?" Program Director Jhani Kaye called the decision "overdue" and that the station was "not leading the way...just playing catch up." The station has received "overwhelmingly positive response" to their decision.

NO MORE FINE PRINT. President Clinton has signed into law the legislation that makes it easier to advertise consumer leases on radio. The provisions, which were piggy-backed on a broad-ranging banking bill, are expected to generate more than \$20 million in new advertising revenues, primarily from auto dealer and manufacturing leasing ads. The new regulations will allow radio advertisers to direct consumers to alternative sources for lease information previously required to be read during the commercial, and were jointly proposed by the Radio Advertising Bureau and the National Association of Broadcasters.

WASHINGTON THIS WEEK

In the wake of the media coverage of the O.J. Simpson trial, and the problems the court has had with it, the Judicial Conference has voted to keep cameras and microphones out of the federal courts. NAB President Eddie Fritts stated in a release, "This is a sad day, and we hope they will reconsider." After a successful three-year experiment that allowed some broadcast coverage, it reportedly took only twenty minutes for the Judicial Conference to deny broadcast coverage of the federal courts.

Promotions and new hires at the Commission: David H. Solomon joins as Acting Deputy General Counsel. For the past seven years, he has been Assistant General Counsel--Administrative Law. Anthony L. Williams as Director, Office of Small Business Activities. He was a Vice President with venture capital firm W&J Management Company.

On September 12, the FCC began making some of its information available through a Fax on Demand service. Initially, the FCC daily digest, FCC news releases, speeches by Commission officials, calendar of events, and some public notices and fact sheets will be available on the system. An index will be available for each type of document. The number is (202) 418-2830.

USA Digital Radio's test of its in-band on-channel DAB system was a success, according to a release this week (would they have said it didn't go well?). The system tests took place at WBBM-FM, Chicago, and an experimental 10 watt AM station in Cincinnati. USA Digital Radio has begun discussions with major receiver and semi-conductor manufacturers regarding chipsets for their new system. Several other DAB systems are being considered by the RBDS subcommittee.

Coming soon...licensees sharing common antenna support structures won't have to refile changes to their licenses as the Commission's Quality Council has approved a proposal to implement a plan that will require tower owners to register the structure if it is used by licensees. The plan will establish a tower owner database, and save the FCC an estimated \$500,000 per year.

ELSEWHERE

The Interep Radio Store announced that it will launch the Radio Interactive Marketing Network (RIMN) to help advertisers and stations fully maximize interactive opportunities in radio. Specifically, the RIMN will help stations develop and expand their interactive capabilities while offering advertisers very targeted and personalized marketing and promotion opportunities not available through other media. The RIMN will be available to advertisers beginning late fourth quarter 1994. For more information contact Interep at (212) 916-0700.

Children's Broadcasting Corp.'s Radio Aahs is claiming new affiliates in Philadelphia, Tulsa, Las Vegas, and Cleveland, although no call letters have been released. The press release claims Radio Aahs now covers 28 percent of the U.S. However, it should be noted that that figure reflects percentage of the U.S. population within the entire ADI for the markets listed, and most affiliates do not cover the entire ADI.

Cadena Radio Centro proudly announced the first Spanish-language national weather service will roll out this month. The service, called ClimaCentro, will do 5 to 30 short customized forecasts per day for the network's 69 affiliates.

James Earl Jones will be hosting "Disney's Wonderful World of Christmas" a three hour radio special to be broadcast during the 1994 Christmas season. The show will combine "best-loved holiday music with magical memories from the Disney archives, holiday recollections from well-known personalities and performances by Walt Disney World's renowned musical talents." ABC Radio will distribute the show.

The House of Blues Radio Broadcasts celebrates its first anniversary on CBS Radio. In response to the positive feedback CBS has added a new Blues Breaker feature which will showcase new releases from veteran artists and rising stars. For more info, call (212) 975-3773.

In a purchase that will allow Fisher Broadcasting to cover all of Montana, as well as Wenatchee, WA, the company will have a complement of 14 radio stations once the deal is done. No word on what happens to Sunbrook's KEEH, Spokane, which is presently simulcasting a non-commercial religion format on a commercial frequency. The Sunbrook stations are:

country KYSN, East Wenatchee, and oldies KXAA, Rock Island, WA
 news-talk KBLG, Hot AC KYYA and rocker KRKX, Billings, MT
 adult standards KXTL, country KAAR and Hot AC KQUY, Butte, MT
 country KGRZ and AC KDXT, Missoula, MT
 adult standards KXGF and AC KAAK, Great Falls, MT

Since they've already got their full complement of FM's in Louisville, Regent Communications thought they'd do the same on the AM side, and have announced their intent to purchase religion outlet WFIA, Louisville from Neon Communications. Price was not disclosed. Interestingly, WFIA's sister is 70's-formatted WQLL, with which Regent is in a SMA. Regent already owns news outlet WDJX, its sister--hot AC WDJX-FM, and country WHKW, Corydon, IN.

The Monterey-Salinas-Seaside market will see a new duopoly as churban KMXZ will pick up KIDD, Monterey and KXDC-FM, Carmel for just over \$1 million from W. Dean LeGras, receiver for the Joaquin Financial Group. KIDD will be spun off to Buckley Broadcasting for \$200,000, which it will combo with AC KWAV, Monterey. Both KIDD and KXDC-FM are silent at present.

Straus Media has doubled up in the Mid-Hudson Valley by buying AC/talker WHUC and oldies WRVW, Hudson, NY from Colgreene Broadcasting. Terms were not disclosed. Straus already owns adult standards WCKL, Catskill and AC WCTW, Kingston, NY.

American Radio Systems has entered into an LMA to take over rocker WCGY, Lawrence, MA from Gowdy Radio Partners. ARS previously announced it will purchase the station to form a duopoly with hot AC WBMX, talker WRKO, and sports WEEI, all Boston.

Arbitron has put their county directory and their radio and television city book on computer in a new program called Find It, a software package that automatically looks up the radio or TV survey geography for any zip code, city or county. It can also display all the zip codes, counties or cities within a selected radio metro, TSA or television DMA. The new software will replace the printed Television and Radio City book, but the "Alphabetical List of Places," the most commonly used section of the report, will be added to the Radio County Directory.

Broadcast Electronics Inc., manufacturer of radio broadcast equipment and systems has purchased Marti Electronics, Inc. Marti will operate as a division of BE. All sales and customer service will continue to be handled through the Marti staff and distributor network. Marti Electronics will remain in Cleburne, Texas.

The Chicago Sun Times reports that Tribune Radio Networks is negotiating to buy Interstate Radio Networks, the Chicago based overnight trucker show. Interstate currently has 60 subscribers and originates from Tribune's WGN.

The Chicago Sun Times also reports that Ross Perot will officially launch his national 90-second commentaries on October 10th through the Tribune Radio Networks. The show will air on Tribune flagship WGN, Chicago, New York's WABC, Atlanta's WSB, Detroit's WJR, Denver's KOA, San Francisco's KGO, Pittsburgh's KDKA, and San Diego's KOGO, to name a few. His weekly program will air Sundays from 7 to 8 p.m. Central Time. All will originate from ABC facilities in Dallas.

First it was Target that got miffed about the use of its name as a radio slogan, now its WaWa???? WCNZ, Chester, PA owner Lloyd Roach picked the WAWA call letters for his AM station, when he got slapped with a cease and desist order from the convenience store change and threatened with a federal lawsuit if he doesn't find another set of call letters. In a story in Inside Radio, Roach said, "There's no confusion--I sell spots, not doughnuts and ... overpriced coffee."

Capital Cities/ABC, Inc. is still on its shopping spree, only it's sort of outside the media business. Earlier, the company bought into an interactive toymaker in California and a Massachusetts-based graphics software firm. This time, they've traded cash and advertising for a stake in Calyx & Corolla, a company that delivers flowers nationwide via FedEx. Capital Cities/ABC says there are two more investment deals coming by the end of the year.

In its second round of showing off this month, USA Digital Radio demoed their In-Band On-Channel DAB system to the NAB Task Force on DAB and the National Radio Systems Committee. NAB was quite impressed, and want you to know that USA Digital will have a booth at the Radio Show in Los Angeles.

Comedy Central and United Stations Radio Networks have reached an agreement to distribute "The COMEDY CENTRAL Minute" to radio stations nationwide. The program will consist of excerpted material from some of the biggest names in comedy. The program will be available to radio stations on a barter basis commencing October 1st. Stations can secure the service on a market-exclusive basis by calling United Stations Radio Networks at (212) 767-1111.

Just when things had settled down over at now-Infinity-owned WPGC-AM & FM, Morningside, MD (Washington, DC), an anti-indecency group calling themselves Americans for Responsible Television has filed a petition asking the Commission to reconsider the sale because the group claims the FCC broke their own rules when it did not release the entire text of its decision to approve the purchase. In a story in Radio & Records, the group blames the FCC for the late-filing of its petition and also called the indecency fine schedule "ineffective."

Westwood One Entertainment announced the introduction of "The Mike Walker Show" a new celebrity gossip talk show to air Monday through Friday from 10 a.m. to noon (ET) starting October 24, 1994. The show will broadcast daily from studios in West Palm Beach and New York with special remotes from anywhere from Los Angeles to London.

StandardNews has added eight new stations to their affiliate list through the SkyLight Satellite Network. The interesting thing here is they're all non-commercial, and won't be able to run the network spots. This is the first we've heard that StandardNews offers its programming to non-comms.

The Associated Press names Christine Gabor to the new position of director of marketing for the broadcast division effective October 12th. Gabor's responsibilities will include market planning, product strategy and sales for AP's radio and television services.
